L. STATE LAW PASSED THAT RESTRICTS THE PROFESSION OR AGENCY: ANY STATE BILL WHICH GETS PASSED THAT RESTRICTS CORRUPT ACTIVITIES OF A GOVERNMENT AGENCY. D. PSYCH INSTITUTION RAIDED: A RAID DONE BY ANY GOVERNMENT OR POLICE AGENCY TO GET EVIDENCE OF CRIMINAL ACTIVITIES WITH PSYCHS OR A PSYCH FACILITY COUNTS 1 POINT FOR EACH PSYCH OR PSYCH INSTITUTION BEING RAIDED IN THE WEEK OF THE RAID.

E. OPPOSITION TERMINAL ARRESTED: GETTING AN OPPOSITION TERMINAL ARRESTED FOR THEIR CRIMES COUNTS 4 POINTS PER INCIDENT IN THE WEEK WHEN THIS OCCURS. THIS, FOR EXAMPLE, COULD BE A PSYCH WHO GETS ARRESTED FOR HIS CRIMES.

K. AGENCY INVESTIGATION (NON CRIMINAL): ANY AGENCY INVESTIGATION INTO AN OPPOSITION TERMINAL COUNTS 1 POINT THE WEEK IT IS STARTED AND AGAIN 1 PIGNT IN THE WEEK IT IS COMPLETED TO A SATISFACTORY RESULT (DAMAGING TO THE OPPOSITION TERMINAL). APPROPRIATE PENALTIES HAVE TO BE TAKEN FOR ANY PRO-OPPOSITION RESULT OF SUCH AN INVESTIGATION. THIS FOR EXAMPLE COULD INVOLVE A PSYCH, A PSYCH INSTITUTION OR A CORRUPT OFFICIAL. BY AGENCY INVESTIGATION IS MEANT AN ACTUAL INVESTIGATION BY OFFICIAL BODIES (OTHER THAN CONGRESS OR PARLIAMENT) SUCH AS GOVERNMENT MEDICAL REVIEWING BOARD, THE GOVERNMENT FINANCE POLICE OR SOME OTHER GOVERNMENT AGENCY.
